**Sub: Upliftment and Popularization of Netball in the states/union territories.**

Respected sir/Madam,

As you all are aware that 9<sup>th</sup> Asian Netball Championship (Women) is being organized at Singapore from 7<sup>th</sup> September to 14<sup>th</sup> September, 2014 and India is going to participate in it. As NFI is committed to uphold the nation's pride at international platforms, a thorough and systematic approach will be followed for the selection and training of the Indian Netball Team. Registration for the above championship is now open. The registration form will be available on the website of NFI from 23<sup>rd</sup> June, 2014. You are supposed to circulate and advertise it via newspapers, website, emails and all other possible means of communication in your state/union territory. Last date for registration is 28<sup>th</sup> June, 2014. The first Trials / camp for the probable players of the Indian Netball Team will be organized at Tau Devial Stadium, Panchkula from 1<sup>st</sup> July, 2014 to 15<sup>th</sup> July, 2014.

Further, you have to call for an executive body meeting in the presence of NFI observer as soon as possible. The agenda of the meeting should necessarily include i) upliftment and popularization of Netball in your state ii) discussion on the annual report of the previous session and iii) organization of the state championships (Senior/Junior/Sub-Junior/any other). It is mandatory to hold this meeting before 10<sup>th</sup> July, 2014. The annual report for the previous session should be submitted to NFI before 20<sup>th</sup> July, 2014 (Kindly ignore, if already submitted)
